H.E. Maritza Chan is Chargé d'Áffaires, A.I. of the Mission of Costa Rica to the UN. As an expert in international peace and security matters, Ambassador Chan has spent most of her career representing Costa Rica in Washington D.C and in New York. She is a champion of the Women, Peace and Security agenda and a founding member of the Accountability,

Coherence, and Transparency Group (ACT), as well as the Group of Friends of Mediation and the Group of Friends of Human Security.

Edgar Vielma Orozco is Director General of Sociodemographic Statistics at Mexico's National Institute of Statistics and Geography (INEGI) He has a Bachelor's Degree in

Mathematics from the University of Guadalajara (UDG) and a Master's Degree in Economics from the Autonomous Technological Institute of Mexico (ITAM). As Director General of

Sociodemographic Statistics he is responsible for the Population and Housing Census, as well as for the Intercensal Survey. In addition, he is in charge of the measurement of employment, occupation and labour informality, migration, vital statistics, monetary and non-monetary income of households, as well as of the variables to measure household overlapping deprivations; among other topics related to the sociodemographic field. In the academic field, he has been a professor in the Department of Mathematics of the University of Guadalajara.

Ambassador Xolisa Mabhongo joined the Permanent Mission of South Africa to the United Nations in New York on May 1 2019 as Deputy Permanent Representative.

Xolisa Mabhongo has served in a number of senior diplomatic positions both in South Africa and abroad. From January 2010 to December 2013 he was South Africa's Ambassador to

Austria, Slovenia and Slovakia. During this time he was also South Africa's Permanent Representative to the UN and Other International Organisations in Vienna (IAEA, CTBTO, UNODC, UNOOSA, and UNIDO). He served as Governor for South Africa to the International Atomic Energy Agency. He was President of the IAEA's 57th General Conference in September 2013.

Ambassador Mabhongo holds a degree of Masters in Public Administration from Columbia University, New York, a Post Graduate Certificate in Diplomatic Studies from Oxford University in the United Kingdom and a Bachelor of Arts Degree from Rhodes University in South Africa.

Professor Gay McDougall



Professor Gay McDougall is Vice Chair of the UN Committee on the Elimination of Racial Discrimination and an international human rights expert. She is an American lawyer focused on challenging inequality related to race, gender, and economic exploitation, both within the United States and internationally. She is a Distinguished Scholar-in-Residence at

the Leitner Center for International Law and Justice at Fordham University. She has received the MacArthur "Genius" Award and the Order of O.R. Tambo Medal for her contributions to the dismantling of Apartheid in South Africa. Professor McDougall holds a J.D. from the Yale Law School and a L.L.M. from the London School of Economic and Political Science.

Dr. Linda Silka



Dr. Linda Silka is SPSSI's President and is Senior Fellow at the Senator George J. Mitchell Center for Sustainability Solutions and Professor Emerita of the School of Economics at the University of Maine. Previously, she was a faculty member at the University of Massachusetts Lowell and directed the Center for Family, Work, Community and served as the Special

Assistant to the UML Provost for Community Outreach and Partnerships. A social and community psychologist by training, much of her work has focused on building community-university partnerships, including at the international level. She has served as principal investigator on U.S. federal grants from the National Institutes of Health, National Science Foundation, Housing and Urban Development, Environmental Protection Agency, and the Department of Education. In the area of climate change, she has worked numerous times at the state-level toward building community resilience. Dr. Silka recently co-led the Mitchell Center's Equity Assessment for the State of Maine Climate Council to evaluate how the plan for addressing climate change issues in Maine is addressing equity issues.



Background

The proposed side event aligns well with the 2022 HLPF theme: "Building back better from the coronavirus disease (COVID-19) while advancing the full implementation of the 2030 Agenda for Sustainable Development." This event is motivated by the UN 2030 Agenda for Sustainable Development's (2015) promise to fulfill human rights to equality and non-discrimination across the 17 SDGs, "leaving no one behind." Despite some advances, systemic racism and racial/ethnic discrimination continues. SPSSI's analysis of the SDG framework showed that although the introduction to the SDGs is visionary in its stated commitment to protect and fulfill human rights for all and to end racial, gender, and other forms of discrimination prohibited by international law, the targets and global indicators developed to evaluate progress on the attainment of the SDGs do not reflect an equally robust focus on this laudatory human rights commitment. Systemic racism and racial/ethnic discrimination continue as sources of oppression, marginalization, exclusion, and inequalities among people in all regions of the world. Psychological and social science findings have documented inequalities in fulfilling basic human needs such as: food, safe drinking water, sanitation, and housing; access to quality education, reliable employment, justice and security, and physical and mental health care; political participation; the impacts of climate change disasters; and experiences of police violence. COVID-19 has

revealed and exacerbated many of these inequalities resulting from systemic racism.

This analysis led to a successful Side Event at the 2021 HLPF, organized by SPSSI and co-sponsored by the Mission of Costa Rica. Mission representatives stressed that changes intended to address issues of discrimination in areas such as education and governance must focus on concrete actions.

Building on the 2021 HLPF side event, this event will focus on strategies for the elimination of systemic racism and the disaggregation of data. Despite a mandate for disaggregated data within the SDGs Framework alongside a call by UN human rights experts (e.g., the Office of the High Commissioner for Human Rights, the Committee for the Elimination of All forms of Racial Discrimination, and the Working Group of Experts on People of African Descent) for action on this mandate, analysis of current global SDG indicators and Voluntary National Reviews (VNRs) reveals limited focus on disaggregated data regarding the prevalence and consequences of racism and related discriminations.

Psychological science is well-positioned to contribute to the global discussion and resolution of issues of systemic racism, bringing to bear its expertise in measurement, sophisticated statistical analyses of disaggregated data, and the translation of scientific knowledge into actionable and equitable social policies and programmes for sustainable development.
